The Fund is a group insurance cover that pays for funeral expenses arising from natural or accidental death for Kenya-Great Britain Diaspora Sacco (KGBDS) member's family including parents and siblings(for nominated beneficiaries).

What are the Benefits?

- · Cash payment for funeral expenses
- Covers natural or accidental death
- Cover extends to HIV & AIDS

What are the features of the cover?

- **Covers** the principal, spouse, children, parents, parents-in-law, and siblings (brothers and sisters).
- **Discounted/ Prorated premium** depending on the date a member joins. (This is a Sacco Group cover that has an Annual cycle that members opt into. It is not an Individual cover).
- Cover allows double covers— couples (if they have Individual member accounts) can individually cover the same nominees and benefits paid to each member in full amounts.
- Members who have paid for at least 3 Sacco shares are eligible for 12 equal monthly instalment to pay the Premium for the Benevolent and Welfare fund membership-This ensures that they don't delay their cover and it can start as soon as their application is approved.
- Term of cover: Annual



QUALIFICATION FOR MEMBERSHIP

A person who possesses the following qualifications shall be eligible for membership: -

- 1. Is within the field of membership consisting of the following common bond; Kenya Citizen living in Great Britain
- 2. Any group that is registered in Kenya e.g Chama, Society, Company but owned by Kenyans Abroad, etc
- 3. Has attained the age of 18 years.
- 4. Is of good character and sound mind
- 5. Pays the entrance fee and share capital as prescribed in these by-laws. Provided that no member shall belong to more than one Sacco society having similar objects operating within the same area of operation.

Share Capital

To qualify as a member, you need to pay for a minimum of 5 shares @kes 10,000 (= kes 50,000) within 12 months.

A member who has paid for 2 shares can join the Group Benevolent and Welfare fund that issues cash benefits when a member loses a loved one (spouse, siblings, parent/s, and Parent/s in-law) in Kenya.
